## BOOKING TERMS

1. The booking must be made via our website, is strictly personal and cannot be transferred to others.
2. A deposit of 30% of the total amount due for the stay is required, and has to be paid within 5 working days from the date of reception of the offer. If we do not receive the required amount within 5 days, the booking will be automatically cancelled. After receiving the deposit, a confirmation e-mail will be sent. The acceptance of the booking and cancellation conditions is understood.
3. A final balance payment equal to 70% of the total amount has to be paid within 7 days before the arrival date. After receiving the amount, we will send the final confirmation. The tourist tax is not included in the booking amount and will be paid on arrival at the reception.
4. You can express your preference for a specific pitch or mobile home number upon payment of € 40,00 fees, to be paid together with the final balance and not refundable. In case of necessity, the Management is always entitled to replace the expressed number with another one of the same typology.

## CANCELLATION RULES

### CANCELLATION POLICY PITCHES

Guests who wish to cancel their booking are entitled to a refund as follows:

- within 7 days before the arrival date the entire deposit will be refunded except for a penalty amount of € 50,00, or the amount paid if lower, as booking fee.
- from the 6th day before the arrival date, the entire deposit amount will be withheld.

### CANCELLATION POLICY MOBILE HOMES

Guests who wish to cancel their booking are entitled to a refund as follows:

- up to 30 days before arrival: full refund of the amount paid;
- from 29th to 15th day before arrival: 30% penalty;
- from the 14th to the 7th day before arrival: 50% penalty
- from the 6th day to the day of arrival: no refund.

- In case of no show without notice, the reservation will be cancelled at 8.00 o'clock the next day.
